ANTI-FREEZE PROTECTION

As is normal at this time of year decisive steps must be taken to ensure that adequate anti-freeze protection is taken in respect of all vehicles in warehouse storage.

As was the practice in the past years, it is your responsibility to see that the necessary protection to the cooling system is taken effective immediately.

For your information, the following are the capacities of the cooling systems of the several models:

Sunbeam Rapier	4
Sunbeam Alpine	4
Humber Super Snipe	7

and it is desired that sufficient permanent anti-freeze is added to the cooling systems to secure a protection to Minus 20° F.

Anti-freeze protection becomes effective immediately at the following warehouse locations:

- Philadelphia
- Norfolk
- *Pensacola
- Boston
- New York
- Baltimore
- * Jacksonville
- * Mobile
- * Tampa
- Detroit

* Note: Anti-freeze protection is required in these warehouse locations to provide ample protection for overland shipments to interior dealer locations where ambient temperature is below that of the warehouse location.

Prior to installation of anti-freeze all hoses to be checked for condition, hose clamps checked for tightness, radiator and cylinder block drain cocks fully closed.

To insure full capacity fill of coolant system, the engine must be started and run to reach operating temperature when the thermostat will be fully open and permit capacity fill.

IMPORTANT:-

Under no circumstances should the cooling system be filled above 1-1/2" below the top of the overflow pipe to permit normal expansion of anti-freeze coolant fluid which is required.
